

COBIS Games 2022 – Virtual Swimming and Cross-Country Meet Terms and Conditions

The COBIS Games, hosted by The British School of Brussels (BSB), will include a virtual Swimming and Cross-Country Meet between 31 January and 28 February 2022. Participating schools are required to run their own meet during this timeframe according to the specified guidelines and submit their scores to BSB / COBIS for ranking.

Registration

- Registration will be open from 11 November 9 December 2021. Schools that wish to participate in the COBIS Games must register at www.cobis.org.uk/games during the stated timeframe.
- Each school may participate in either the Cross-Country or Swimming Meet; schools cannot participate in both.

Eligibility

- Each school may enter up to the stipulated number of students (as per the brief available at <u>www.cobis.org.uk/games</u>), with no minimum number of participants from each school.
- The COBIS Virtual Games is open to COBIS member schools, including Applicant schools. Each school
 with a registered COBIS account should participate as an individual school.
- Only students born between 1 September 2007 and 31 August 2010 may be entered into the Middle School Team.
- Only students born between 1 September 2003 and 31 August 2007 may be entered into the High School Team.
- COBIS / BSB reserve the right to request proof of age of participating students.

Rules

- All schools must abide by the rules which are set out in the Swimming and Cross-Country Meet briefs, available at www.cobis.org.uk/games.
- Results should be evidenced to avoid any disputes over submitted entries. Swimming meets should be recorded, and cross-country should be evidenced through a GPS watch or tracking app, e.g. Strava. COBIS / BSB may request this evidence to verify results.

Cancellation

 COBIS and BSB reserve the right to cancel this competition if insufficient registrations are received, or if circumstances do not allow the competition to take place.

Data Sharing and Processing

- The full name, age, school name and score of participating students will be published on the COBIS and BSB website and social media. This information may also be published and promoted at the COBIS Annual Conference in May 2022 and in other COBIS-related publications. By entering the competition, the teacher confirms that the necessary permissions have been (or will be) sought from students and/or their parents to publish this information for such purposes. - In order to administer this event, COBIS and BSB will collect the following personal information:
 - o Students: name, age, gender, swimming/running result
 - o **Teacher**: Head teacher name, lead teacher name, email and job title
- This data will be shared between COBIS and BSB for the administration and delivery of the event. COBIS and BSB will have a data sharing agreement in place to protect the transfer of this information. This information will not be passed by COBIS to any other parties.
