### What's iQTS?

iQTS is a new, UK government-backed international teaching qualification which is recognised by the Department for Education (DfE) as equivalent to English qualified teacher status (QTS).

iQTS will be delivered by DfE-approved iQTS providers, working in partnership with excellent schools and selected in-school mentors around the world.

With the help of your expertise and experience, we can make gold standard teacher training accessible to candidates anywhere in the world.

### What's involved?

# DfE has designed iQTS to be a high-quality professional teaching qualification with the flexibility to adapt to the trainee's local context.

The course, which lasts one academic year full time, or longer part time, consists of:



A minimum of 120 days in placement schools, with practical classroom experience plus support and feedback from an in-school mentor.



Training delivered by an approved iQTS provider, either in person or remotely.



**Regular feedback and assessment**, conducted by an approved iQTS provider.



**Rigorous quality assurance** through an international inspection framework.

#### What's needed from you?

As a partner school working with an iQTS training provider, you would need to:

- Facilitate the required classroom experience
- Deliver **in-school mentoring**, provided by an experienced member of your staff
- Allow trainees to be observed in school as part of the provider assessment process
- Work closely with the iQTS training provider to maintain standards
- Supply feedback to DfE to help improve iQTS for future candidates
